Gail Baker attended the library Feb 23, to sign her new Flin Flon Pictorial History Book. We served coffee and cookies, and brought up pictures from the Archives for patrons to view. We had a good turnout, and the seniors really enjoyed the outing.

AJ's was called March 16th, as the air quality seemed off. He reported that the mixed air temp sensor was not working. He installed a new one, and tested the fresh air exchange.

Buz and I attended the Town of Creighton Chambers on March 14th, to receive a \$17,951.44 Grant presentation form Pahkisimon Neye?ah Library System. The Town of Creighton receives the funds, and forwards them on to the library.

I applied for used computers, under the Computers for Schools program, (CAP Site Program), and received two newer computers, for the Archives room.

Since Dec 1, 2011, we have had 7 Incident Reports of drunken/disorderly patrons. Six of those have involved the police. Workplace Health & Safety rules changed June 2011, requiring all Employers complete a Violence Prevention Policy. Leslie Beck offers this type of training.
