1. Administrator attended CFAR January 23 to discuss library programming.

- 2. As per Administrator's request, Colin Fisher, manager of Stittco, attended the library on January 24 to check our propane meter.
- 3. Administrator attended the Fun in the Winter Sun Pre-school Wellness Fun Day at the Community Hall on January 25 from 1-6pm. The library had a booth complete with games, crafts, and superhero capes.
- 4. Flin Flon Public Library partnered with Read to Me program for Family Literacy Day which was held at the library on January 27th. The library served snacks and invited numerous guest speakers from the community, and 45 individuals participated.
- 5. The library has been running a Love to Read contest for the month of February complete with reading bucks and prizes. For the month of February 608 children's books were checked out. For the adults we are running a Reading is Sexy contest with prizes in conjunction for reading banned/challenged books.
- 6. Administrator was called to the library on Saturday, January 28th to deal with an overflowing downstairs toilet during a rental. VA was contacted and corrected the situation.
