Audit:

Discussion on the 18% increase in audit fees over last year. Workmans' Compensation

Board:

Bunny Burke will write a letter to the Workmans' Compensation Board requesting comparative information on fee schedules for compensation coverage. The rate charged appears to be excessive for a Library of this size.

Janitorial

Supplies:

Gretta Redahl explained the increase in the janitorial supplies is caused by the cost of purchasing more paper towels and tissue for the washrooms. A great number of the public are directed to the Library, due to the lack of public washroom facilities on Main Street. Gretta will bring this matter to the attention of the Chamber of Commerce, the City of Flin Flon and the Main Street Board of Management.

Creighton Grant:

The town of Creighton, Saskatchewan increased their operating grant by \$3,000.00 for 1986. The province of Saskatchewan will match this increase in 1987. A letter of "thanks" will be sent to the Creighton Town Council for the increase. The circulation statistics will be included. The members of the Board and the Library Administrator express a special "thank you" to Joe Sattleberger for his presentation to the Creighton Town Council and province of Saskatchewan on behalf of

the Library.
